This form is validating the permission of a parent/legal guardian to have their student involved in the activities organized by FBCH both on and off the campus of the church. This means the parent/legal guardian, upon the signing of this form, cannot hold said church liable for injury, loss, or damage to person or property. However, the parent/legal guardian will be notified of any injury, loss, or damage to person or property if such an event would occur in the presence of an adult representative of FBCH. The notification of this adult representative will be based upon the seriousness of the concern. Any activity that will occur outside the campus of the church will require an additional notification from a parent/legal guardian that the student is participating in said activity. This type of notification is supplemental to this document and will ensure that both the parent/legal guardian and the church have come to an agreement over the student's participation in an activity. If a student has on their person anything illegal or harmful (such as drug(s) paraphernalia or weaponry) that is determined to be potentially threatening according to the standards of the adult representatives of FBCH, the parent/legal guardian of that student will be notified and the student may be dismissed from further activities. If a student is involved in any sexual behavior or has on their person anything of a sexual nature (pornography, sexually explicit images in cellphone, etc.) determined to be reprehensible by the standards of the adult representatives of FBCH, the parent/legal guardian of that student will be notified and the student may be dismissed from further activities.
